- 1. Call to order: Chairperson Rasmussen called the meeting to order at 3:30 pm.
- 2. Roll Call: Members present: Supervisors Christopherson, Creaser, Noreen, Plouff, Prochnow, Quinn, Rasmussen, Schaefer and Solberg
- 3. Approval of Minutes: Supervisor Noreen offered a motion to approve the minutes of the **June 5** meeting. Supervisor Solberg seconded the motion. Motion was approved by a voice vote.
- 4. Staff Reports:
 - a. County Manager
 - 1) 2013 Budget Planning: Tonya reminded members that there are still a few committees that need to schedule their meetings for August. Budgets are due Friday, July 13 and to Board on July 25.
- 5. Consideration for Actions to be taken by the Executive Committee:
 - a. Related to the debate on amending the United States Constitution to establish that: only human beings, not corporations, are entitled to constitutional rights, and money is not speech, and therefore regulating political contributions and spending is not equivalent to limiting political speech. (This item could result in a resolution being brought before the Board of Supervisors.): Supervisor Plouff moved to adopt the resolution supporting an amendment to the Constitution of the United States to provide that corporations are not persons. Motion was seconded by supervisor Christopherson. Motion approved by a voice vote
